Rolf To Review 5½ Great Years, And Look To Future

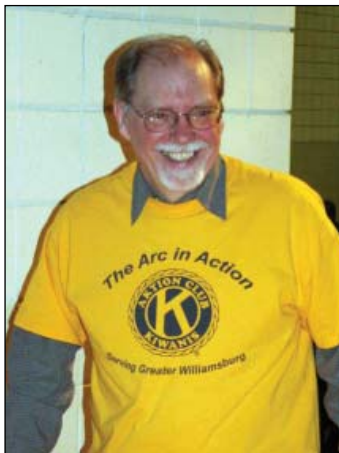

Williamsburg. We began with 15 members and now have 26.

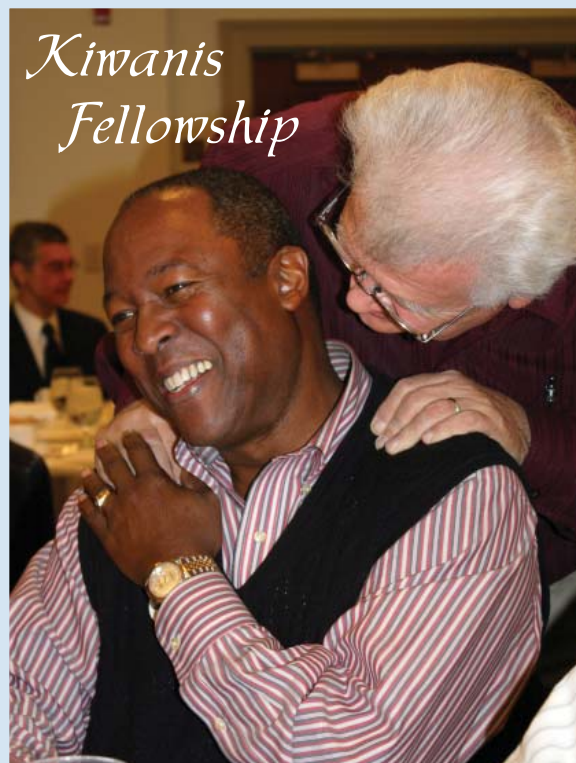
